2020 Theme: "My Life, My World, My Dreams."

Deadline: Postmarked by Wednesday, March 18, 2020

Prizes:

- There are three prizes in each of three age categories, nine prizes in all.
- Age categories are 5-8, 9-12, and 13-18.
- The following prizes will be awarded in each age category: 1st place: \$500 2nd place: \$250 3rd place: \$100
- All nine winners will be honored at the Youth Awards Ceremony in the summer 2020.

Eligibility:

- Any FSYP member under age 19, excluding those whose parents are FSYP Board members or employees. FSYP family membership dues must be current as of March 18, 2020 for your application to be considered. To join FSYP please see our website at: www.fsyf.org
- A contestant may submit only one entry per contest.

Artwork Specifications:

- Artwork must address the given theme.
- Only flat media will be accepted.
- Any medium (pastel, watercolor, oil, pencil, crayon, digital art, etc.) is acceptable.
- Submissions must be entirely or essentially the artist's original work. Found material such as bits of wallpaper, photographs or printed matter may be used, e.g., in a collage, but must be presented in an original way in the context of an essentially new composition.
- Dimensions of submitted work may not exceed 22" x 28".

Use of Artwork:

- Artwork will become the property of FSYP and/or SDFCU and will not be returned to artist. FSYP may use submitted artwork in FSYP-related publicity or products and retains the right to sell the artwork for fund-raising purposes.

Submitting Artwork:

- All entries, including digital artwork, must be mailed. Artwork must be postmarked by the stated deadline of March 18, 2020. Any artwork that is not postmarked by March 18 will not be judged.
- Please ALSO email the Art Contest entry form and a photo of your artwork to FSYP@FSYP.org by March 18, 2020.
- A completed Entry Form must accompany the artwork and be attached to the back of the submission.
