Outdoor Court and Athletic Field Regulations

Our community values a healthy and safe environment. We ask that you not smoke within 50 feet of playgrounds, courts, athletic fields, pavilions and recreation areas. Thank you.

1. All permits are subject to cancellation by the Department of Parks and Recreation (DPR).
2. All schedule changes and cancellations must be made in writing at least 72 hours in advance to the Facilities Scheduling Office: FacilitiesScheduling@arlingtonva.us.
3. Customers may cancel their reservation with a minimum of 72 hours notice prior to the day of the event. A \$20 administration fee will be deducted from all refunds. There will be no refund issued if the cancellation is not received within 72 hours in advance of the facility use.
4. In the event of inclement weather, please call (703) 228-4715 prior to heading out to your scheduled reservation.
5. Rainouts must be reported no later than the next business day to the Facilities Scheduling Office in writing: FacilitiesScheduling@arlingtonva.us In the event of a rainout, the permit holder must notify the scheduling office when the rainout occurs. This must happen in order to receive credit towards another date. Synthetic fields remain open during inclement weather unless closed by DPR Staff.
6. Permit holders are responsible for the conduct of their group.
7. There shall be no noise makers of any kind including but not limited to horns, drums, instruments, megaphones or any other amplification systems. Amplification of any kind must comply with County code and receive prior approval by DPR.
8. DPR reserves the right to charge customers for excessive damage to equipment or facilities at the cost to replace the equipment.
9. Cars must be parked in designated areas and users are encouraged to abide by all zone parking restrictions or run the risk of being ticketed or towed.
10. Park Users choosing to park their personal vehicles next to an athletic field or court do so at their own risk; balls from an athletic field or court can exit these locations.
11. Do not park on grass areas or interfere with bike trails and/or residential driveways. Please note: Parking is not guaranteed and is available on a first come, first serve basis.
12. Nothing may be offered for sale, sold or rented in or upon any regulated open space, without authorization.
13. There should be no grilling on site without prior written permission from DPR.
14. It is illegal to possess or consume alcoholic beverages or illegal substances at County facilities. Alcohol is permitted at Fort
